**NOTE: Total surface area of all structures shall not exceed 40% coverage of the unit/site area. No more than 40% of the lot may be covered by structures, plus "non-absorbent" materials such as concrete, asphalt, etc. Pavers are not considered non-absorbent material in this calculation.**

**A cable/utilities location search/confirmation must be conducted prior to doing work in the easement area (5 ft. on all sides) of your lot. This includes removing trees, grinding stumps, placing pavers, etc. Failure to conduct a cable/utilities location will result in the unit owner paying for the repair of damages caused to these cable/utilities.**
